# 2. Registration of the financial administration portal user

**Registration** of **Financial Administration Portal** user (hereinafter 'FAP') is a process that begins on **the website of Financial administration**.

If the user is the owner of a chip-activated identity card, i.e. an **electronic identification card** ("eID card"), the user does not need to fill in their identification data in the registration form but the data on the eID card is automatically filled-in in the registration form via the eID card, the Central Public Administration Portal ("CPAP") and the Register of Natural Persons ("RNP"). After registration, the user can log into PIZ at FAP without visiting the TO/CO.

#### Automatic authorization:

In the case of **registration of natural persons**, if the applicant checks the option in the registration form **'I request access to authorization for personal proceedings'** and at least one of the options **'with the tax office/with the customs office'**, the system will automatically attempt to identify a new user in the financial administration environment, i.e. in its registers, upon completion of registration. If a relevant person and entity are found in the registers and comply with all the conditions for the creation of an authorization, **an authorization with the legal title of the "Personal proceeding" shall automatically be created.** A notification shall be sent to the applicant on the success/failure of the automatic authorization.

• If a user registers an eID card and an authorization for personal action is automatically created, the user can communicate with the financial administration electronically immediately after registration.

#### **2.1.** Registration with eID card

A pre-condition is that the user has the necessary eID card software, chip card reader and eID card installed on their computer. The necessary software is available at <u>https://www.slovensko.sk/sk/na-stiahnutie</u>.

#### 2.1.1. Registration with eID card – identity card

 The user starts a web browser and enters the FA web address – <u>www.financnasprava.sk</u>. The FA home page opens.

- 2. Press (in the top menu) to display the version of FA home page in English.
- 3. By pressing the button (top right corner), the user will see the menu and can select the registration method at the FAP, in this case the first option **Registration using an identification card with an electronic chip (elD card)**.



- 4. The user logs in **to CPAP** using the eID card by entering the security personal code (PSC) "Login with Slovak ID" option .
- 5. FAP will automatically retrieve the necessary user data from the eID card as well as the current address from the Register of natural persons (RNP).
- 6. The data obtained shall be completed in the relevant fields of the registration form, with Name, Surname, Birth number and Date of birth being uneditable for the applicant, other data being editable. The field "Country" will be filled in and the Date of birth field will be filled in according to the Birth Number.

The user will complete missing data needed for FAP registration (e.g. e-mail, password, personal identification code, ...):

#### House number,

Identification type (predefined selection Birth number)

- If Slovakia is selected, Identifier type is set to the **Birth number**, and cannot be switched to the Identification number. The Birth number must be entered in the form of yyyyy/xxxx.
- If country other than Slovakia is selected, the Identifier type will be set to the **Identification number**, and it is not possible to switch it to the Birth number.

#### Date of birth

- If the Identifier type is set to **Birth number**, date of birth is non-editable and after completion of Birth number is automatically filled in.
- If the identifier type is set to **Identification number**, the date of birth is editable and must be completed.

**Password** (user-selectable) – must contain at least 8 characters , at least 1 character from the lower case set [a-z], at least 1 character from the upper case set [A-Z], at least 1 digit from the number set [0-9]. Do not use diacritics or spaces.

Confirm password - the user enters the password he has selected again (correctness check),

**Personal identification code** - (chosen by the user), this is additional data of the registered person, which must be entered in the range of up to 20 characters. This code is used in the personal internet zone - when adding a registered user as another authorized user acting on behalf of the subject, it is necessary to know his PIC.

I request access to authorization for personal procedures - this option is intended for users who are natural persons. If checked by the user, he must check at least one of the following options:

with the tax office - the user checks if, at the same time as the registration of the person, he also applies for access to authorization to personal action, i.e. the user will act on his behalf. After the registration is completed, if all conditions are met, the person's authorization for the subject will be created automatically, i.e. the user of FAP services will be able to act towards the tax office in person as a tax subject for himself immediately after the registration process.

#### 2.1.2. Registration with eID card – foreign ID card

- The user starts a web browser and enters the FA web address <u>www.financnasprava.sk</u>. The FA home page opens.
- 2. Press (in the top menu) to display the version of FA home page in English.
- 3. By pressing the button (top right corner), the user will see the menu and can select the registration method at the FAP, in this case the first option **Registration using an identification card with an electronic chip (eID card)**.

- 4. The user logs on to CPAP using his eID card "Login as resident of EU Member State" option
- 5. FAP will automatically retrieve user data from the eID card.

#### **2.2.** Possible cases in the registration process

a) If you try to register a person who has already been registered in the system, you will see a notice of failure due to data duplication when you press the "Register" button at the end of the registration form.

Three cases of duplication can occur:

If the user fills in the same first name and surname combination together with an identification number, personal identification code or date of birth (for foreign persons), the system will display the following message at the bottom of the form:

Registration with the currently entered registration data is not possible. There is a registration in the system of a person with the same data Name and Surname in combination with at least one of the data: Identification number, Date of birth (if the Identification number is filled in), Personal identification code. Please contact the financial administration call center.

If the user with a unique first name and surname fills in a birth registration number that already exists in the form, the system returns a duplicate notification:

1 There is a registration of person with the same data in the system. Contact the financial administration call center.

In both cases, a notification email entitled "Rejection of registration by the system" will be sent to the user's email address.





If a user with a unique first name and surname enters a duplicate identification number, the system displays the "Notice" window:



If the "**Yes**" button is confirmed, the user can continue the registration process. If the answer is "**No**", the registration process is terminated and the user's homepage of the portal is displayed.


b) In case of registration with an eID card (ID card), if **the connection to RNP is not functional**, the following message will appear to the user



After confirming with "OK", the user can continue to complete the eID card data - Name, Surname, Birth number, Date of birth and Country into the registration form, where the Name and Surname, Birth number and Date of birth will be uneditable. The remaining fields must be filled in.

#### 2.3. Activating registration


1. After successful registration, a message will appear informing you that the registration will be completed by means of an activation e-mail that will be delivered to the user at the entered e-mail address.



By confirming the button , the user finishes the first part of registration on the FA website.

#### 2. Registration confirmation in activation e-mail.

By sending the registration form, the system records the data entered by the user and sends the user an **activation e-mail** with the subject "Confirmation of registration" to the e-mail address entered in the registration form.. This e-mail is used to verify the e-mail address entered by the applicant in the registration form. It provides information on the successful record of registration data and at the same time the user is invited to **confirm registration** by clicking on the activation link.



Confirmation of registration must be completed **within 24 hours** of sending the registration form.

**If the user is not able to activate the registration within 24 hours,** the system will invalidate the activation link contained in the activation e-mail, and the user will receive information in the e-mail with the subject "Automatic cancellation of registration".

#### 3. Activating registration.

If the user **continues the registration process by clicking on the activation link**, a window appears with non-editable basic registration data (Degree, Name, Surname), which the user submitted in the registration form.




Information about the cancellation of the registration process by the user will be sent to the e-mail box with the subject "Cancellation of registration by the applicant".

If the user has entered **incorrect data**, the user can repeat the registration **immediately**.

b) If the user wishes **to continue the registration process**, by pressing Activate registration registration will be confirmed.

After activating the registration, a window will appear informing about the registration activation and sending of a second **activation e-mail** to the user.



4. Activation e-mail (second):

In case of registration with eID card, after activating the registration, the second activation email with the subject "Confirmation of successful registration with eID card" will be sent to the user's e-mail address specified in the registration form, and informing that the registration was successful and the user can start using his FAP account:

# 2.4. Notification e-mails in case of an application for access to authorization for the personal action of natural persons

#### 1. Authorization for personal action with the tax office:

If a user who is a natural person – entrepreneur – has checked the option in the registration form "I request access to authorization for personal proceedings" and the option "with the tax office", the system will attempt to automatically create an authorization for the person and the subject with the legal title of action Personal action, once the eID card registration is complete.

# 3. Logging on to FAP after registration via eID

#### 3.1. Login – eID card

**By sending** a second activation e-mail, the user **has completed the registration** on the public website of the financial administration.

The e-mail contains a **Login** link to connect the user to the FAP-login interface. To log in, he then selects **Identification card with an electronic chip (eID card)**.


The user logs in to CPAP using the eID card by entering the personal security code (PSC) – "PSC" option. After successful authentication verification, he is automatically logged in to his PIZ.

#### 3.2. Login – Identifier and password

For the next login, he can also use the assigned User ID, which is displayed after logging in to the PIZ with the title, name and surname in the upper right corner next to the button,

together with the password entered by the user in the registration form. For such a login, select **Identifier and password** from the menu.

- 1. The user is on the Home screen of the FA-web page <u>www.finacnasprava.sk</u>.
- 2. Press (in the top menu) to display the version of FA home page in English.
- 3. By pressing the button (top right corner) a menu will be displayed to the user where he selects the Login method. The OSS user is only allowed to log in by selecting the option Identifier and password.



4. The user inserts the user ID and Password and clicks the "Login" button.

## 4. User log out

User logged in and found in PIZ. Click on the button in the upper-right corner. It will then be redirected to the FAP cover page in English.
